

# 2021 Campaign Expenditures and Contributions Statement



## Candidate's Statement of Campaign Expenditures and Contributions

**Directions:** Each candidate for election to the Board of Education whose campaign *expenditures* and/or *contributions* exceed \$500 must complete and file sworn statements at least **three times**: the first statement, on or before the thirtieth day preceding the election (i.e., by **April 19, 2021**); a second statement on or before the fifth day preceding the election (i.e., by **May 13, 2021**); and a third statement within twenty days after the election (i.e., by **June 7, 2021**). In addition, any contribution or loan in excess of \$1,000 that is received after the most recent filing deadline, but before the election, must be reported within 24 hours after receipt. Except as noted herein, these statements must be filed with **two separate parties**: 1) the District Clerk, Ithaca City School District, 400 Lake Street, Ithaca, New York 14851; and 2) the Commissioner of Education, Room 3055, Cultural Education Center, Empire State Plaza, Albany, NY 12230. If the campaign expenditures made by you or made by others on your behalf, with your approval, exceed \$500 and/or if you have received campaign *contributions* in excess of \$500, the law requires you to "itemize" all such *expenditures* and/or *contributions* (as applicable) on this statement. Your itemized statement of campaign *expenditures*, if required, must set forth all money and/or valuable goods paid, given, expended or promised by you and/or others on your behalf, with your approval, with respect to your nomination and/or election to the Board of Education. Your itemized statement of campaign *contributions*, if required, must include the dollar amount of any receipt, contribution or transfer, plus the fair market value of any receipt, contribution or transfer other than money, the name and address of the transferor, contributor or person from whom received, and if the transferor, contributor or person is a political committee as defined in N.Y. Election Law Section 14-100 (1), the statement must include the name of and the political unit represented by the committee, the date of receipt, the dollar amount of every expenditure, the name and address of the person to whom it was made or the name of and the political unit represented by the committee to which it was made and the date thereof. If neither your campaign *expenditures* nor *contributions* exceed \$500, then you need only file the statement below with the District Clerk (not required to file with the Commissioner of Education) indicating only that your *expenditures* and *contributions* (as applicable) were not more than \$500 (i.e., no itemization is required if \$500, or less).

It is not necessary to itemize data already reported in a prior statement, but each statement must include a summary of all expenditures and contributions and other particulars reported in any previous statements.
